### 1. Introduction

This report gives an update on the current status of PRoFouND Deliverable D7.4: 'Networking event to encourage partnership working' (scheduled to be delivered by month 34).

The Online Innovation Factory (OIF) platform developed as part of Deliverable 7.1, together with Deliverable 7.2: 'Promotion of at least one falls prevention reference site, project or technology' provide the basis for the delivery of D7.4, in that the seminar presentations and presence at networking events outlined in this report were used to showcase these aspects of ProFouND WP7.

The delivery of D7.4 builds upon the launch of the OIF at the inaugural European Falls Festival (EUFF) held in Stuttgart on 24-25<sup>th</sup> March 2015 as detailed in D7.3.

During the course of the remainder of 2015, and into early 2016, the presence of the OIF and the ProFouND project was promoted across a number of channels, and at events across three separate member states.

The public area of the PRoFouND website acts as the face of the project providing information to the community and the general public about the project. It is primarily directed at falls-related healthcare professionals and practitioners and also aims to inform members of the public (older people and their formal and informal carers) as well as European Institutions and falls-related organisations.

The OIF areas of the website can be viewed as a public resource but the additional functionalities (including the ability to initiate topics, manage discussion on own topics, contribute to other users topics and see comments) are only available to users logged in to the user login area of the PRoFouND website <a href="http://profound.eu.com/forums/forum/innovation-factory/">http://profound.eu.com/forums/forum/innovation-factory/</a>.

Users are advised upon logging in to Profound that any information that they share on the website, either in the form of discussion content, uploaded research & briefing materials, or video sharing file formats, is, unless specifically stated, liable to be copied and redistributed by other users given the collaborative nature of the website. This also applies to users of the Online Innovation Factory.

## 2. OIF Promotion & Networking events

Working in partnership with the ProFouND consortium and the European Connected Health Alliance (ECHAlliance) International Network of Connected Health Ecosystems, the OIF, its functionality and the promotion of best practice reference sites, was introduced and promoted to a range of stakeholders.

#### 2.1 Connected Health for Falls Prevention & Monitoring

This seminar, part of the Connected Health Innovation Centre seminar series held at the University of Manchester, took place on 16<sup>th</sup> September 2015.

Over 50 delegates attended from a range of backgrounds including academia, charity/third sector, the public sector (local authorities & NHS), commissioners and providers of services and industry.

The seminar highlighted the work of ProfouND, together with the FARSEEING initiative through presentations from Dr Helen Hawley Hague (University of Manchester) and Professor Dawn Skelton (Glasgow Caledonian University).

The OIF was discussed as part of the presentations, focusing as they did on ICT solutions for falls detection, monitoring & prevention.

#### 2.2 International Network of Connected Health Ecosystems

The ECHAlliance is a pan European 'connector', whose Ecosystem network brings together, across more than 25 Ecosystems in Europe, the USA, Canada & China, a community of stakeholders interested transforming the delivery of health & social care through the use and deployment of digital, mobile, and wireless technology.

Each ecosystem is a permanent multi-stakeholder arrangement, bringing together groups that meets at least four times a year in each region or country in which they operate. They bring together in a single place and at the same time multiple stakeholders united across a common theme.

Through engaging with the ECHAlliance network of connected health Ecosystems, WP7 has showcased the work of ProFouND and fostered engagement with a wide community across Europe who are working on collaborative research and development of technology for falls monitoring and prevention.

Details of the three promotion and networking events in Nice, Valencia, and Manchester are detailed below.

#### 2.2a: Nice, France

The work of WP7 and the OIF formed part of the agenda for the inaugural Nice Ecosystem, the first of its kind in France, on 10<sup>th</sup> September 2015. The event focused on e-health and active ageing.

Through connections with the Manchester Connected Health Ecosystem, ProFouND & WP7 was presented to the delegates in the morning session ('An International community on Digital Health and Active & Healthy Ageing') as part of the 'Greater Manchester: case study of an existing ecosystem and projects' presentation (Annex B).

The OIF was highlighted as a valuable resource for falls professionals across academia, industry, and the healthcare and public sector.

The press cutting below from the ECHAlliance website (log in required) highlights the scale and breadth of the event, as well as drawing attention to the promotion of the work of ProFouND.

More than 150 organisations joined the launch event of Nice's Ecosystem, exploring the strengths and challenges facing the region in digital health, active and healthy ageing and the Silver Economy.

## The multi-stakeholder working group participated in a whole day of presentations, debates and networking opportunities, showcasing:

 Policy-makers, such as the NICE City council and metropolis, the Regional Council of PACA, the Regional Health Agency of PACA, the European Commission;

- Health & social care providers, such as the University hospital of NICE;
- Research organisations, such as the INRIA and the I3S lab;
- Expert centres, such as France Silver Eco and the CIU Santé;
- Private insurance/mutual fund, AG2R La Mondiale;

• Companies, such as Healthways, Tunstall, Orange Healthcare, Sanofi, Accelis, Ignilife, Feeligreen;

Clusters and innovative projects supports, such as BPI France, the AAL Programme, and the
competitiveness clusters Eurobiomed and Solutions Communicantes Sécurisées (SCS).

Fellow ECHAlliance Ecosystem, the Manchester Connected Health Ecosystem, joined the speakers to present an update of the achievements of theManchester Ecosystem and its work on the PROFOUND EU project on falls prevention.

#### 2.2b: Valencia, Spain

As part of the promotion of the 'Integrated Care at Home in Departamento de Salud Valencia-La Fe' best practice reference site as contained in the European Innovation Partnership Active & Healthy Ageing (EIP-AHA) report 'Reference Sites: Excellent innovation for ageing - European Guide', WP7 engaged with a number of partners in Valencia. This included Dr Lucas Donat Castello from the Hospital at Home and Telemedicine of Health Department La Fe, working in the research unit headed by Dr. Valdivieso and Dr. Traver on the EIP AHA Valencia Reference Site. The work of ProFouND and WP7 is of particular relevance given the work their unit is doing on predictive models of factors related to complex chronic patients, and also in the field of remote monitoring of elderly patients.

The Valencia reference site formed part of the agenda as one of the innovative projects currently being undertaken in the region.

Discussions also took place prior to the event, and during the course of, with Dr Antonio Cano MD, Professor of Obstetrics and Gynaecology, Department of Paediatrics, Obstetrics and Gynaecology, University of Valencia, and project lead for the Valencia Ecosystem.

WP7 presented at the launch of the Valencia Ecosystem on 15<sup>th</sup> October 2015. The agenda for which is at Annex C.





#### 2.2c: Manchester, United Kingdom

The Manchester Connected Health Ecosystem took place on 14<sup>th</sup> January 2016 on the subject of 'Active & Healthy Ageing', with presentations on the work of ProFouND and the OIF and an interactive workshop session (Annex D).


ProFound consortium director Prof. Chris Todd outlined the technology elements of the programme (the ProFouND website, information forum, ProFouND APP, and use of social media) before Carmel Dickinson & Dan Morley (WP7) presented in more detail on the OIF.

A breakout group in the workshop discussion focussed on 'Falls Prevention & Monitoring' with the work of the OIF being highlighted in this discussion as a vehicle for sharing best practice and building communities of interest across geographic, institutional & thematic boundaries.

The Manchester Ecosystem was attended by over 65 delegates from a range of backgrounds across local government, NHS, industry and academia. A full list of registered delegates is at Annex E.

All registered delegates were sent follow up details of the event slides together with further promotion of the OIF (Annex F).

The OIF has been well received to date, with 11 challenges currently under discussion.

- industry engagement to provide a multinational perspective
- discussion on how align the outcomes of this debate with the Renovated A2 Action Plan, including general/specific objectives specifically reflecting the A2 future vision on technologies

It will be promoted via invitation to a broad range of partners including the AHA A2 Action Group, and the ECHAlliance Connected Health Ecosystem network.


